How to file a Title VI/ADA complaint with Choices for People Center for Citizens with Disabilities, Inc.:

1. Download and complete the ADA Complaint Form from Choices' website at <https://y3a352.p3cdn1.secureserver.net/wp-content/uploads/2023/12/Choices-for-People-Centers-Title-VI-Complaint-Form.pdf>. Drop off or mail the completed form to Matthew E. Evans, 1840 Hwy 72 E., Rolla, MO 65401 or email it to her at the following email address: director@choicesforpeople.org.
2. In addition to the complaint process at Choices for People Center for Citizens with Disabilities, Inc., complaints may be filed directly with the Federal

Transit Administration, Office of Civil Rights, East Building, 5th Floor – TCR
1200 New Jersey Ave., SE Washington, DC 20590.

3. Complaints must be filed within 180 days following the date of the alleged discriminatory occurrence and should contain as much detailed information about the alleged discrimination as possible.
4. The form must be signed and dated and include your contact information.
